## **RESOLUTION NO. 16-**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING THE MEAN AUTO OCCUPANCY BY LAND USE AND THE RATE PER DAILY TRIP UNDER THE TOWN OF MIAMI LAKES MOBILITY FEE ORDINANCE; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** the Town Council has adopted Ordinance No. 16-\_\_\_, known as the "Town of Miami Lakes Mobility Fee Ordinance"; and

**WHEREAS,** the Town of Miami Lakes Mobility Fee Ordinance requires that the Town Council establish the "rate per daily trip" and the "mean auto occupancy by land use" by resolution; and

**WHEREAS,** the Council finds that the *Southeast Florida Regional Travel Characteristics Study*, published in October 2000, is the best available data to establish the mean auto occupancy by land use for the Town of Miami Lakes;

**WHEREAS,** the Town Council finds that the method for determining the rate per daily trip in accordance with the Town of Miami Lakes Mobility Fee Ordinance results in a rate per daily trip of \$168.84.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Establishing "Mean Auto Occupancy by Land Use Type." The Town Council of the Town of Miami Lakes hereby establishes the "mean auto occupancy by land use type" under the Town of Miami Lakes Mobility Fee Ordinance as set forth in Exhibit "A" attached hereto and incorporated herein.

<u>Section 3. Establishing "Rate Per Daily Trip."</u> The Town Council of the Town of Miami Lakes hereby establishes the "rate per daily trip" under the Town of Miami Lakes Mobility Fee Ordinance as \$160.00 per daily person-trip.

<u>Section 4. Implementation.</u> The Town Manager and/or his/her designee is authorized to take all actions necessary to implement this resolution and the Town of Miami Lakes' Mobility

Fee Mean Auto Occupancy by Land Use Type and Rate Per Daily Trip as set forth in Exhibit "A" attached hereto.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
