A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, SEEKING DISCUSSION WITH STATE LEGISLATION AND THE FLORIDA DEPARTMENT OF TRANSPORTATION; PROVIDING FOR A CONSENSUS TO BE REACHED REGARDING THE PALMETTO EXPRESS LANES; AND IMPROVING THE DRIVER EXPERIENCE; PROVIDING FOR AN EFFECTIVE DATE. (COUNCILMAN COLLAZO AND VICE-MAYOR RODRIGUEZ)

WHEREAS, during the September and December 2019 Town of Miami Lakes (the "Town") Council meetings, the Town Council deliberated measures to mitigate traffic impacts from the creation of toll express lanes on Florida State Road 826 (the "Palmetto Expy"); and

WHEREAS, during the September 2019 Town Council meeting, instruction was provided to staff to open dialogue with Florida Department of Transportation ("FDOT") regarding the design and location of express lane onramps on the Palmetto Expy; and

WHEREAS, during the December 2019 Town Council meeting, the Town Council provided instruction for passing of a resolution in support of Florida House Bill 829, which aims to remove the Palmetto Expy express lanes; and

WHEREAS, the Town Council finds that the operation of express lanes on the Palmetto Expy, without necessary infrastructure improvements has compromised the experience and safety of drivers using the Palmetto Expy; and

WHEREAS, the Town Council desires to support measures to open dialogue with FDOT regarding the function of the Palmetto Expy and new legislation regarding the removal of the express lanes.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing recitals are true and correct and are incorporated herein by reference.

<u>Section 2. Support for HB 829 Express Lane Removal.</u> The Town Council formally supports House Bill 829, which aims the removal of Express Lanes from Florida State Road 826, also known as Palmetto Expressway.
