Crime	Auto Theft (51 incidents as of 7/31/2018. <i>Date of last incident 07/31/2018</i>)
Statistical Info	Up 7 as opposed to prior year to date
Trends	Vehicles stolen overnight from commercial plazas and apartment complex parking lots. Several auto thefts involve vehicle owners leaving their keys in their vehicles. Vehicles that would only have been burglarized are being stolen.
Action Taken	<ul style="list-style-type: none"> • Officers have been assigned directed patrols. They are requested to remain highly visible at the various commercial plazas, apartment and townhome complexes, and hotels in their respective areas. • Current auto theft information as well as BOLOs and Informational flyers are regularly shared with the TML Officers. • Officers continue to investigate Tow Trucks that are operating overnight. • Decoy vehicles continue to be deployed for enhanced visibility. • Comp Details are being scheduled for increased police visibility. • Auto Theft Detectives responded to each car dealership and informed the managers of recent auto theft incidents and ways to improve their procedures. In February and again in March, two vehicles were stolen at car dealerships. The vehicles were left unlocked with keys inside prior to being loaded on trailers for transport.

Location	16435 NW 67 th Ave
On Saturday, July 28, 2018, A TML Officer arrested a juvenile subject for CCF. A local business (Casavana) contacted the police and requested their presence prior to terminating an employee. An employee had observed a firearm in a backpack that the employee was carrying. Upon making contact, the subject admitted the backpack and firearm were his.

Location	16960 NW 86 Court
On Thursday, July 24, 2018, A TML Detective submitted an arrest affidavit for an April 7, 2017, residential burglary incident. On April 19, 2017, the detective arrested two subjects for an April 6, 2017, burglary incident and impounded a subject's cellular phone. On April 7, 2017, there was a similar residential burglary in the same area. A warrant was obtained for the phones contents. The phone's content extraction revealed photos taken on the day of the burglary of a firearm taken from the residence. Surveillance images also revealed the subject's vehicle in front of the burglarized residence. Based on the aforementioned, the subject was charged accordingly for the additional burglary.

Location	14252 NW 83 Court
On Thursday, July 24, 2018, A TML Detective submitted an arrest affidavit for a July 12, 2018, auto theft incident. Officers were dispatched to 14252 NW 83 Court reference a stolen vehicle. Shortly thereafter, OnStar was utilized and located the vehicle abandoned in an apartment complex in Hialeah. Detectives responded and processed the vehicle. A latent impression that was lifted from the vehicle identified the arrestee. The recovered vehicle was also parked approximately 100 feet from the subject's front door.	
Day / Date / Time	Saturday / 07/21/2018 / 5:24 am
Location	16630 NW 83 Place (Residence)
Officers were dispatched to the listed location reference a violation of an injunction order. Victim was in her home when she heard someone trying to open her front door. She checked her ring video and saw that the arrestee (who was known to her) had attempted to enter her residence by pulling on the front door knob. She called police and units responded. A TML Officer located the arrestee at 154 Street NW 77 Avenue and took him into custody. Arrestee was charged with Burglary (Occupied/Residential/Attempt); Aggravated Stalking; and Violation of Injunction.	
Day / Date / Time	Thursday / June 7, 2018 / 2:30 pm
Location	9067 NW 169 Street
On Thursday, June 7, 2018, TML Detetctives arrested two subjects involved in a residential burglary that occurred the day prior. On that day, a subject was observed on video knocking on the victim's front door and then walking away. The residence was occupied by a 15 year-old who was sleeping. The subject then entered an unlocked rear door and stole jewelry from the residence. The victim later saw his property listed for sale on OfferUp. After coordinating with Hialeah Police, two subjects were arrested for the burglary.
