RESOLUTION NO. 20-

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING THE RATE PER DAILY TRIP UNDER THE TOWN OF MIAMI LAKES MOBILITY FEE ORDINANCE; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes Mobility Fee Ordinance requires that the Town Council establish the "rate per daily trip" by resolution; and

WHEREAS, the Town Council has adopted Ordinance No. 16-192, known as the "Town of Miami Lakes Mobility Fee Ordinance"; and

WHEREAS, On December 10, 2019 the Town Council established the rate per daily trip at \$449.76 based on a master plan which included projects from the Smart Plan; and

WHEREAS, those projects from the Smart Plan were not yet properly adopted by the Town Council, and were therefore not properly added to either the Town's Capital Improvement Element (CIE), or the Transportation Master Plan (TMP), and therefore could not be used to calculate the fee at the time; and

WHEREAS, the Town Council understands that excessively increasing the rate per daily trip may result in an unwanted reduction of business and economic development in the Town; and,

WHEREAS, the Town Council finds that the method for determining the rate per daily trip in accordance with the Town of Miami Lakes Mobility Fee Ordinance results in a rate per daily trip of \$209.52.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

<u>Section 2. Establishing "Rate Per Daily Trip."</u> The Town Council of the Town of Miami Lakes hereby establishes the "rate per daily trip" under the Town of Miami Lakes Mobility Fee Ordinance to be Two Hundred Nine Dollars and 52/100 (\$209.52) per daily person-trip.

<u>Section 3. Implementation.</u> The Town Manager and/or his/her designee is authorized to take all actions necessary to implement this resolution and the Town of Miami Lakes' Mobility Fee Rate Per Daily Trip as set forth in Exhibit "A" attached hereto.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
