Statistical Info	Up 10 as opposed to prior year to date
Trends	Vehicles stolen overnight from commercial plazas and apartment complex parking lots. Several auto thefts involve vehicle owners leaving their keys in their vehicles. Vehicles that would only have been burglarized are being stolen.
Action Taken	<ul style="list-style-type: none"> • Officers have been assigned directed patrols. They are requested to remain highly visible at the various commercial plazas, apartment and townhome complexes, and hotels in their respective areas. • Current auto theft information as well as BOLOs and Informational flyers are regularly shared with the TML Officers. • Officers continue to investigate Tow Trucks that are operating overnight. • Decoy vehicles continue to be deployed for enhanced visibility. • Comp Details are being scheduled for increased police visibility. • Auto Theft Detectives responded to each car dealership and informed the managers of recent auto theft incidents and ways to improve their procedures. In February and again in March, two vehicles were stolen at car dealerships. The vehicles were left unlocked with keys inside prior to being loaded on trailers for transport.

Miami-Dade Police Department Narcotics detectives conducted a narcotics investigation and obtained a consent to search the above listed residence based on information provided by TML officers. Detectives recovered jars of marijuana from within the residence, and 37 plants were recovered from the backyard. The subject was arrested and charged with possession of cannabis – more than 20 grams.

Location	16500 Bridge End Road
Miami-Dade Police Department Narcotics detectives conducted a narcotics investigation and obtained a consent to search the above listed residence. Detectives recovered approximately 141 pounds of suspect marijuana, marijuana oil, marijuana wax, and marijuana edibles; and seized \$36,925.00. The subject was arrested and charged with trafficking marijuana.

Location	6491 Cow Pen Road
Pursuant to an Ex Parte Order, an adult male respondent was taken into custody and transported to the V.A. Hospital. Fitting the criteria for a the issuance of a Risk Protection Order (RPO), detectives on scene petitioned the courts and an RPO was issued for the seizure and safe keeping of all the respondents firearms and ammunition. Detectives were able to serve the respondent with the RPO and took custody of the firearms and ammunition.

Location	6800 Main Street – Victoria's Secret
TML police responded to a theft in progress at the Victoria's Secret on Main Street, and arrested a subject for petit theft. Because it was verified that the subject had two prior convictions for petit theft, the responding officer charged the subject under a third degree felony statute. The subject had a minor child with her, so she was also charged with contributing to the delinquency of a child.
